



**at the Depot Arts Center, Anacortes, WA - December 2010 – January 2011**

## SHOW GUIDELINES

1. Participation in the Depot Arts Center Show is available only to NWBW and CBBG Members. To join, visit our web site: <http://www.nwbasketweavers.org/>
2. Jury selection is based on quality of artwork submitted. All work submitted must be original (no reproductions), not done under supervision, not made from kits or patterns. All work must be suitably prepared for installation. The curator reserves the right to deny entry if any work is deemed not suitable for display or too difficult to install. Entries must have been completed within the last 3 yrs. All entries will be juried by the images submitted. If, upon delivery, an accepted work is found to have been misrepresented by the digital image, it may be disqualified.  
*NWBW and the jurors reserve the right to select one or more submission images for use in show marketing and publicity materials including but not limited to post cards, posters, website, and media articles.*
3. Applications must be postmarked no later than **August 25, 2010**. Artists will be notified of acceptance on Sept. 25, 2010. Notification will be by e-mail unless a SASE is included with the application.
4. There will be a 40% commission taken by the Depot Arts Center on any sales, the artist will receive 60% of their listed sale price. Please take this into consideration when pricing your work.
5. Both the Depot Arts Center and NWBW will provide media coverage for this event. All NWBW members will be given the opportunity to use informational postcards to be mailed to patrons. Postcards addressed by the artist and returned to the Depot Show Committee by October 25 will have postage paid by the Depot Arts Center. Artists are welcome to send postcards out themselves as well, as suits their needs. Artists who are accepted into the show will be able to request quantities of postcards when they are notified of acceptance.
6. Artwork Delivery: Artwork may be delivered by the artist to the gallery on Nov. 30-Dec. 2, times to be set later. Other delivery options are: artwork may be delivered to the November guild meeting, 11/10, if previously arranged. Artwork may be shipped by UPS with a prepaid return mailing label. Shipped entries must be sent in reusable containers (NO PACKING PEANUTS). The address for shipped work will be provided with the acceptance information.
7. The show opening will be on Friday, December 3, 2010, 6 to 9 pm. The show will be part of the Anacortes First Friday Gallery Art Walk. This will be an opportunity for the public to meet the artists. All NWBW members are encouraged to attend the opening and share in the celebration.
8. NWBW is responsible for providing food at the opening. This will be a potluck of appetizer type dishes. The Depot Arts Center will supply a no host wine bar.
9. Pick up of unsold work: unsold work may be picked up at the gallery on February 1st. Artwork that was shipped by UPS will be shipped back that week. If arranged in advance, some artwork can be delivered to the February guild meeting.

**All applications must include the following:**

✘ **Images:** Submit up to 5 digital images. All submissions must be on a CD. Images must be saved in the correct horizontal or vertical orientation for viewing. Image file specifications are as follows: JPEG format at maximum quality, with the longest dimension no larger than 1024 pixels, at a resolution of **300** dpi. Do not send original artwork, print photos or slides. Images should be saved with the following file name format: Last Name\_First Name\_Entry Number(1 thru5) Example: Doe\_Jane\_1.jpg Label the outside of the CD with your first and last name.

✘ **List of Images:** list images on the application above. Numbers must correspond to the image numbers on the CD. Please include photo credit for each image. **The price you give on this list is the sale price that will be put on the item; you will receive 60% of that value if your piece sells.**

✘ **Artist's Bio or Resume:** Optional. Please limit to one page.

✘ **Application Fee** (non-refundable): A check for \$15 payable to the NWBW with this application for jury process and entry fee.

✘ **SASE** if you would like to have your Notification of Acceptance letter sent by USPS.

✘ I agree to the terms in this application and in the Depot Art Show Guidelines.
